Photo and Video Policy

Twins Trust Policy

Our policy when planning to use an image or video in the public domain is to obtain consent by the appropriate person using the consent form below.

The purpose of this consent form is to provide information to the person giving consent so that they are aware of where their photo may be used and they can make an informed decision.

The consent form must be complete before the photo/video is used.

Why does Twins Trust need images?

We support families across the UK via our support services, factsheets, courses and webinars, as well as campaigning to improve research into the risks that multiples face during and after birth. Images help promote our work and help us continue to provide services for all families of multiples.

How will the images be used?

We use images in a range of materials to promote Twins Trust and the services we offer. This may include mail, printed publications (e.g booklets and campaign materials), media work (press), electronic materials (social media, website, email and presentations), advertisements and display materials (leaflets, brochures and posters).

We cannot accept responsibility for photos and content being shared or repurposed by third parties.

How long will consent last?

Consent will continue with no limit. Image consent can be changed or withdrawn at any time by notifying Twins Trust. If you wish to withdraw consent, please email pressoffice@twinstrust.org. We cannot withdraw images already published.

Who can give consent?

It is good practice to involve children and young people in the consent process of their images.

- Children under 18: A signature of the parent/legal guardian must be obtained
- Children under 12: Inform them how their images may be used and respond to their feelings.
- Those over 18 who understand what they are consenting to can sign the form themselves

For images where the subject's face cannot be seen or is obscured a consent form is still required as it is possible that they are still recognisable by friends and family.

Where are files kept?

All photos and consent forms will be stored digitally in a secure folder by our Digital Officer.
